This is a great opportunity to promote your business at a well-recognized and fun event!

Last year was a great success! Our attendance of nearly 3,000 people was a fantastic crowd. We worked hard to organize and promote the event effectively. UnTapped is the largest outdoor music Festival in the Tri-Cities. We expect this year to be even bigger and better.

In order to participate in the 2010 UnTapped Blues Festival, you must fill out the enclosed form and send your [\\$225.00 Registration Fee](#) to the address below. We will include you on our "Event Temporary Kennewick Business" license and insurance rider for the festival. Set-up can begin anytime after 8:30 am on May 8th, the gates to the public open at Noon and the show ends at 11pm. A brunch is provided at 10:00 am for set-up staff.

Please note that we restrict vendors to one vendor for each type of product. For example, if we have a vendor that has signed up to sell candles we will not accept a second vendor that sells candles. We also give preference to our long-time vendors.

Vendors are responsible for their booths (set up and removal, as well as maintaining a clean booth). Vendors are expected to be ready to sell products beginning at Noon and extending until the event ends at 11 p.m. Finally, we will not be using script for food or non-food vendors so come prepared to make change.

Application Deadline: All applicants must submit a **COMPLETED** application and the required fees by March 31, 2010.

Non-Food Vendor Fee: The fee for this year will be **\$225.00**. There is no additional sales fee.

Business License: We will include you on our Event Temporary Kennewick Business License for the festival.

Sales Tax: Applicants are responsible for all sales taxes (State and local).

Set-up: Set-up will begin anytime after 8:30 am on Saturday, May 9th. Gates will open to the public at noon and the event ends at 11:00 pm.

Attending Staff: Names (Maximum of 4) of all attending staff are needed for "Will-Call" gate (West Gate)

Vendor Gate: Vendors will enter the fairgrounds via the "West Gate" for set up. Vendor staff entering the fairgrounds during the event will enter via the same gate.
